## **JPA Eliminated!!! HB 1479 Passed the Senate!**

## **4<sup>th</sup> DTaP Dose is Focus of Immunization Initiative**

Washington and Oregon are teaming up to fight pertussis and protect children. Pertussis rates are increasing in Washington State and at the same time, immunization rates for the 4<sup>th</sup> dose of DTaP lag behind the first 3 doses. Nearly 20% of Washington children have not received the 4<sup>th</sup> dose of DTaP by age 3.

In March and April, 2005 the state Immunization Program will launch a campaign to heighten awareness of health care providers and parents about the importance of the 4<sup>th</sup> DTaP, typically offered at age 15-18 months.

## **New Meningitis Vaccine Protects 11-12 Year Olds**

The Food and Drug Administration recently approved a new and more effective bacterial meningitis vaccine appropriate for ages 11-55 years. The vaccine, Menactra, meningococcal conjugate vaccine (MCV4) protects longer than the previous vaccine available. The Advisory Committee on Immunization Practices (ACIP) recommends Menactra for ages 11-12 years and 15 year olds. Currently, the CDC is considering whether to make the vaccine available under contract for the Vaccines for Children Program. The CDC does not anticipate adding Menactra to the Recommended Childhood and Adolescent Immunization Schedule until 2006, the schedule's next printing.

The incidence of meningitis in the U.S is about 3,000 cases per year, with about 300 fatalities. The highest incidence, 5.1 cases per 100,000 populations is in college freshmen who reside in dormitories. All meningitis vaccines protect against certain strains of bacterial meningitis, but provide no protection for viral meningitis.

## **JCAHO Joins Push for Malpractice Reform**

The Joint Commission on Accreditation of Healthcare Organizations (JCAHO) has proposed a series of changes in the nation's medical liability system as a major step in solving what officials describe as crisis preventing physicians from providing the best patient care. In a recently-published policy paper, JCAHO concluded that the current liability system fails patients because it does not deter negligence, provide justice or fairly compensate victims of medical errors. The commission's report — "Healthcare at the Crossroads: Strategies for Improving the Medical Liability System and Preventing Patient Injury" — recommended several demonstration projects to test alternatives to the current system, including early settlement offers, "no-fault" administrative systems, health courts and the use of court-appointed, independent expert witnesses. ## **Leavitt Named, Confirmed as HHS Secretary**

Michael O. Leavitt was confirmed and sworn in as the 20th Secretary of the U.S. Department of Health and Human Services on January 26th; just one month after President Bush nominated the former Utah governor to replace outgoing Secretary Tommy Thompson. Leavitt was most recently serving in the Bush Administration

as the administrator of the Environmental Protection Agency.

Leavitt's experience as Utah governor included the drafting and passage into law of "Healthprint," a comprehensive, incremental approach to health care improvement in the state. Since it was passed in 1994, Utah has more than 400,000 additional people with health insurance, marked increases in the number of children with health care coverage, dramatically improved immunization rates and per capita cost of healthcare 25% below the national average. He was also chosen by the nation's governors to represent the states in Congress on welfare reform, Medicaid and children's health insurance during his term.

As head of HHS, Leavitt now oversees an agency with a budget of nearly \$550 billion and 67,000 employees and is charged with implementing a broad healthcare and public safety agenda, including implementing the Medicare prescription drug benefit, preparing for any national health emergency, and pursuing medical research.
