Legislative Update

We want to focus this article on two different areas of work that are undertaken by the Department of Health and the Legislature during the time period between legislative sessions, referred to as the interim. First, we will review for you the extraordinary amount of work being performed by the Department of Health in its sunrise reviews, and we'll follow that with a summary of key interim studies being conducted by the Legislature.

Department of Health. The Department of Health is undertaking a number of sunrise reviews that may be of interest to ARNPs. These reviews are mandated by the Legislature anytime legislation is introduced which either expands a health care professional's scope of practice or creates a mandated health benefit.

1. SB 6522 Maternity Services. This legislation amends the earlier adopted "drive-by delivery" statute. It goes further by saying that health carriers must provide coverage for maternity care. ARNPs and CNMs are specifically covered as "attending providers" when they have hospital privileges and when they're included in the provider network of the carrier providing coverage. We anticipate that ARNPs United will be working with the Women's Health Care Coalition to support this legislation. A preliminary review of the proposed legislation indicates some changes are needed to avoid the applicability of maternity coverage to only hospital births. The first public meeting to gather information and comments will be held in early June, and this review will be concluded in September.

2. HB 2594 Contraceptive Services. This legislation requires health carriers to provide coverage for contraceptive services...which is not specifically defined. We anticipate that ARNPs United will be coordinating our efforts with those of the Washington State Council on Family Planning, which is the lead entity advocating for this issue. The first public meeting to gather information and comments will be held in early June, and this review will be concluded in September.

3. SB 5471 Osteoporosis Treatment & Prevention. This legislation requires health carriers who provide hospital, medical or surgical coverage to include coverage for the prevention, diagnosis, and treatment of osteoporosis. "The services may include, but are not limited to, visits to health care professionals, reimbursement for scientifically proven bone mass measurement, which is bone density testing, and United State Food and Drug administration-approved medications." The

initial meeting on this legislation is scheduled for June, and this review will be concluded in July.

4. HB 2286 Naturopathic Scope. This legislation amends the scope of practice for naturopaths...who will now be known as naturopathic physicians. This follows the lead of the optometrists and podiatrists who are now also referred to as physicians. In addition, the legislation broadens their scope of practice. Currently, naturopaths are allowed to prescribe some legend drugs, and this would extend their scope to all legend drugs and Schedules IV and V, controlled substances. There are other changes which expand their scope to include defining "minor office procedures" to mean "limited surgical care", removal of limitations on intermuscular injections, and the addition of x-ray interpretation. The Washington State Medical Association has strong objections to this proposed legislation, and has contacted us asking for our opinion. The Legislative Committee will be reviewing this legislation in great detail at its June meeting, as well as the naturopaths' reasons for believing these changes are necessary, and will make a recommendation to the Board. This sunrise review is also commencing in June, and is expected to be concluded by October.

5. HB 2540 Dental Anesthesia. This legislation mandates that health carriers covers dental anesthesia for children. This is an important issue for CRNA's because they need to be specifically included as anesthesia providers. The Washington State Dental Association, who is the advocate for this legislation, has indicated their intent to include CRNA's, but of course, we will be monitoring this closely. The review of HB 2540 starts in July and will be concluded in October.

6. SB 6566 Mental Health Parity. This legislation, as revised, will mandate that health carriers cover mental health services at parity with physical health services. ARNPs United is working with a coalition of other interested parties. This review will start in July and conclude in November.

7. SB 6617 Eating Disorders. This legislation will require health carriers to provide coverage for eating disorders which are defined as anorexia and bulimia. This review is being performed concurrently with mental health parity.

8. SB 5675 Medical Rehabilitation Services. Tired of making no progress before the Legislature, the rehab associations are proposing legislation that would mandate coverage for their services in the Basic Health Plan. This review will begin in July and conclude in November.

9. **SB 5978 Medical Rehabilitation & Chiropractic Services.** Moving right along, this legislation mirrors SB 5675 and also adds chiropractic services.

10. **HB 2865 Optometrists.** This unique legislation would in essence allow the Board of Optometry to define as optometric practice anything which is taught in optometry schools that is approved by the Board. This review begins in May and will conclude in July.

The sunrise process includes the proponents preparing a report explaining and justifying why the legislation would benefit the public. This report is discussed with ample opportunity given for rebuttal by those groups that either outright oppose the legislation or have suggestions for modifications to the proposed legislation. The Department reviews all the information and writes a report with a recommendation that the Legislation be adopted, amended, or not adopted. We'll keep you posted on the results of these reviews.

Legislature's Interim Studies. Here's a brief summary of some of the interim studies that the Legislature will work on during the Summer and Fall of 1998.

→ **Dual diagnosis.** This study will explore the problems encountered by persons who have both mental illness and substance abuse problems in receiving appropriate treatment.

→ **Medical treatment of children in DSHS custody.** Continuing questions are being raised about the use of antipsychotic or psychotropic medications to treat children who have mental illness or behavioral problems.

→ **Managed care regulation.** Over the past several years, increasing numbers of bills have been introduced to deal with this complex issue, but few have passed. A wide variety of issues will be reviewed including the extent to which current managed care requirements address quality assurance.

→ **Telepractice and professional licensing.** New technologies have drawn attention to providing interactive

long distance health services to consumers. This is a minefield for legal issues related to professional licensing. For example, does a health care professional living in another state, giving advice to a Washington resident need to be credentialed in Washington.

→ **Drug affected infants.** Because legislation addressing this issue was essentially vetoed by Governor Locke in 1998, there will be continued meetings with interest groups to develop policy solutions that are acceptable to all parties.

→ **Certificate of need.** The budget directed the Joint Legislative Audit and Review Committee to study the certificate of need program, to include hospitals, ambulatory surgery centers, kidney dialysis centers, home health and hospice agencies.

→ **Long-term care.** SSB 6544 called for a comprehensive study of this state's long-term care system to be undertaken by a joint legislative and executive task force. Initial finds of the task force are due January 1, 1999, with final recommendations due by December 12, 1999. Key objectives of the study which will be:

- ◆ Review quality and safety standards for all types of long-term care facilities and services regulated or delivered by DSHS
- ◆ Evaluate the need for uniform assessments to determine long-term care needs for state-funded clients
- ◆ Evaluate alternatives for reorganizing and reforming current long-term care administration and service delivery
- ◆ More long-term care. SSB 6544 also directed DSHS, the Department of Health, the Nursing Care Quality Assurance Commission, together with adult family home, boarding home, and in-home personal care providers to review caregiver training standards.
- ◆ Monitor joint legislative task force on nurse delegation.
- ◆ Monitor Department of Health study on self-directed care.
- ◆ Explore ways that access to hospice services can be increased.
- ◆ Monitor activities in other states regarding end of life care.
- ◆ Review need for legislation to prevent discrimination based on genetic information.
- ◆ Background checks. A comparative analysis of various background check statutes will be compiled to assist legislators in determining if additional legislation is necessary.
- ◆ Monitor issues relating to insurance fraud committee by health providers and study options for addressing them.
- ◆ Pain management. Monitor the development of pain management guidelines by the Department of Health, and conforming policies by the Department of Labor and Industries.

Book Review of Pulse

Pulse, a new book by nurse author Echo Heron, starts off with a bang, two murders in the first 5 pages. The plot follows a convoluted course through the hospital corridors, and out into the San Francisco community. Adele Monsarrat, RN the nurse protagonist is savvy and assertive, ultimately solving the murders and mystery that surrounded the deaths. The story is complete with subtle humor, which will be appreciated by any nurse that has ever worked in a hospital. Some of the characters lead wilder lives than I recall from my hospital days, and stretch the believability of the reader. This does make for interesting reading when added to a high-stress workplace with drugs, sex and unusual spiritual practices. If you're looking for a murder mystery written by a nurse **Pulse** fills the prescription.

The author, Echo Heron, was a critical care nurse in the San Francisco Bay area for 17 years. She has written the bestselling book **Intensive Care: The Story of a Nurse, Condition Critical: The Story of a Nurse Continues** and **Mercy**.
